## Policy for environment, occupational health and safety & energy

As a company operating internationally, we endeavor to combine commercial success with responsible conduct vis-à-vis people, the environment, and society. We are aware of our responsibility that stems from such worldwide and long-term challenges as demographic change, climate change, and the limited availability of resources. Based on the values of our ReWire sustainability program, we strive for sustainable business growth that reconciles the economic, ecological, and societal demands on us. Our Code of Conduct and its implementation play a key role in this respect. We offer our customers reliable, high quality, and environmentally compatible products, which we make based on observing applicable health and safety regulations. We are working on continually improving the measures that contribute to enhancing our social and ecological commitment. To do so, we make use of internationally recognized management systems. This policy gives us the framework for setting and checking corresponding targets.

## Our operating principles:
